

**Entries**

All local artists are invited to submit up to three entries . . .

- original work only (no prints or giclees)
- all 2 dimensional work must be dry and wired for hanging.
- maximum size of 2-D work, including frame, 36" wide x 42" high.
- maximum size of 3D work is 36"high x 18"wide x 18"deep. Maximum weight is 75 lbs. Artist must supply appropriate display unit or pedestal
- Glass and jewelry artists will supply appropriate display unit or case.
- Decision of Artist's Eye Staff is final when accepting work for jurying.

**Prizes**

- Cash prizes (still to be determined) will be given for best of show and first place in all categories. Ribbons will be awarded for second, third and honorable mention in all categories.

**Categories**

- Acrylic
- Watercolor
- Mixed Media (2D)
- Digital
- Glass
- Oil
- Pastel
- Photography
- Sculpture
- Jewelry

*Note: Categories may be eliminated or combined due to quantity of work submitted in each.*

**Procedure**

• Deliver all entries to Showcase Gallery,  
3851 S. Bear Street,  
South Coast Plaza Village, Santa Ana  
Saturday, June 20  
between 9 a.m. and 12 noon.

- Attach a 3"x5" card to the back of each 2 dimensional artwork, listing the artist's name, address, phone number, e-mail address, title, medium and price. Jewelry and sculpture 10 lb. or less can have card attached with string.
- Heavy 3 dimensional pieces *must* have the card attached to the artwork by tape or a string so it may be read without lifting the piece.
- Work not juried into show must be picked up Saturday afternoon, June 20, between 4:30 and 6 p.m.
- Reception is from 5 to 7 p.m. Saturday, July 11
- End of show pickup is Sunday, July 19 from 11:30 a.m. to 3 p.m. A \$5.00 per day storage fee will be charged for each piece left after that date.

**Notes**

Unless indicated, all work is assumed to be "for sale" at the price indicated by the artist. OCFA will retain 20% of the sales price if a cash or check sale and 25% if the sale is by credit card. *No artwork, including sold artwork may be removed until the end of the show.*

**Fooding and Reception**

All participating artists must sign up for at least one 4 hour work shift for each accepted piece, contribute \$5.00 each for the purchase of reception "goodies", and are expected to invite guests and collectors and personally attend the reception on July 11 from 5 to 7 p.m.
